I. Welcome/Updates/Intra-System Communication

All members present introduced themselves, some provided updates:

- EllenThornton-Love: Lane County Behavioral Health has received a grant for 18-25 year olds with serious mental health illness; also doing other work with Developmental Disabilities & youth with serious mental health issue(s)
- David Saez: Centro Latino Americano has received a grant to provide Life Skills Training services.
- Janey Stroup: Bethel School District has spots open in WIOA; GED program starting
- Jason Jones: OYA has a continued focus on isolation at closed custody, dealing with behaviors and coming up with new responses since can no longer isolate; issue with drugs getting into MacLaren.
- Heather Murphy: CASA is implementing foster futures curriculum, a national curriculum.
- Mike McCart: OSLC received grant money for drug and alcohol treatment program.
- Wesley Lucas: Introduced as the new staff member for the committee.
- Nathaline Frener: Youth Services will be adding two 72-hour shelter beds on campus for youth who are brought to Youth Services on charges by law enforcement and who should be released but end up being detained because no parent, guardian, or other appropriate placement is available.

Nathaline Frener shared that on Sunday, a youth who was committed to OYA but had not yet been transported escaped from detention. Jason Jones noted that delays in transport have been due to an overall paperwork backup. Judge McAlpin raised the possibility of alternative court procedures that would allow for more efficient processing.

III. Presentation by Parent Project – Brent Vaughan

Brent Vaughan facilitated a hands-on activity, and presented the attached Powerpoint. Noted that they are hoping to offer the Parent Project program to a larger group.

IV. Presentation by A Family For Every Child – Anthonia Amrusko

Anthonia Amrusko presented about the mentor-assisted life skills program and opportunities for youth who have not yet been matched to a mentor. A point of curiosity is that they are seeing an improvement in life circumstances, but not seeing improvement in class grades. Noted that the main reason that mentorships end is that parents pull their youth out.

V. Presentation by Centro Latino Americano – David Saez, Estela Vega-Rios

Presented the attached Powerpoint. They are looking to expand reach and engagement with parents; the focus in 2019 includes mental health, partnerships, and a youth leadership model.
