### LEC Nominations December 5, 2003

The LEC has 4 members whose terms expire 12/31/03. In addition, 4 other members have resigned or are resigning at 12/31/03. The LEC needs to make nominations for seven of these eight seats. The eighth seat is chosen by the Lane County Board of County commissioners. In addition, the LEC will need to nominate a new chair and vice-chair.

We ran a notice in the City / Region section of the Register Guard on October 24, 2003. In addition, the vacancies were posted to the LCOG web site on October 12, 2003.

We received a total of 11 applications for the open positions. All applicants are highly qualified and would make excellent contributions to the LEC. The applicants are as follows:

1. Jim Ramseyer: Existing LEC member, retired Blachly-Lane CEO
2. Glenda Poling: Existing LEC member, Lane Metro Partnership
3. Mike Sullivan: Existing LEC member, City of Eugene
4. Mike Galvin: Existing LEC alternate, Lowell School Board and Lowell Fire District
5. Tim Black: Existing LEC alternate, UofO Office of Government Affairs
6. John Sullivan: Existing LEC alternate, Filbert farmer, retired Smith Barney executive
7. Joshua Greene: Existing LEC alternate, Port of Siuslaw commissioner
8. Randy Derrick: Lane County MIS manager
9. Mitch Wilkinson: UofO Native American Studies program director
10. Mike Blomme': Monaco Coach facilities manager
11. Phillip Hudspeth: Economic Development Director for Congressman Peter Defazio

The LEC is required to be broadly representative of the geographic areas of Lane County. In addition, the LEC is expected to be representative of various subgroups including business, government, education, labor, finance and the professions. Based on these requirements of the LEC bylaws and a detailed review of all applicants, the LEC nominating committee makes the following recommendations:

- (1) Reappoint the three existing members to new three year terms (**Glenda Poling, Jim Ramseyer, Mike Sullivan**)
- (2) Appoint **Tim Black** to the seat formerly occupied by Michael Redding. Tim represents the Office of Government Affairs at the University of Oregon. Tim has regularly attended LEC meetings as the alternate for Michael Redding.
- (3) Appoint **John Sullivan** to the seat formerly occupied by Scarlet Lee. John has attended LEC meetings for the last year as the alternate for Scarlet Lee. He volunteered for several subcommittees during the year and has been a regular contributor at LEC meetings.
- (4) Appoint **Mitch Wilkinson** to the seat formerly occupied by Don Hampton. Mitch is a Native American and brings his experience as director of Native American community development at the University of Oregon. Mitch can also represent east Lane County.
- (5) Appoint **Mike Blomme** to the seat formerly occupied by Alex Pawlowski. Mike is facilities manager for Monaco Coach in Coburg. He is a member of the Monaco senior management team and supervises a work force of over 200 people. He will bring representation of North Lane county and of the important motor coach industry.
- (6) Appoint **Phillip Hudspeth** as a new ex officio member. Phillip is the point person for economic development efforts for Congressman Peter Defazio. Phillip's presence should build greater cooperation between our local economic development efforts and those at the federal level.
