approved by Transportation Planning Committee (TPC) or CLMPO Staff  
September 16 – October 21, 2021

*The following proposals required TPC approval (pending completion of the public review period):*

**21405 – LTD**

**LTD frequent transit network (2020)**

Description: Various safety and amenity improvements to the frequent transit network including shelter or station improvements, transit signal priority, wayfinding signage, bicycle lockers, ADA improvements, enhanced lighting, and other improvements that will facilitate connections, improve safety, or allow for strategic investment.

Funding: \$371,484.82 (Urban STBG, FTA-5307)

Amendment: Cancel 2021 “other” phase; add 2022 construction phase funded with \$244,784.72 Urban-STBG (incl. match) and \$126,700.10 FTA-5307 (incl. match). No change to project total.

Note: FTA requires all projects involving construction elements to include a construction phase in the TIP.

**21406 – LTD**

**LTD frequent transit network (2021)**

Description: Various safety and amenity improvements to LTD's frequent transit network

Funding: \$620,577.29 (FTA-5307)

Amendment: Change description to read “Various safety and amenity improvements to the frequent transit network including shelter or station improvements, transit signal priority, wayfinding signage, bicycle lockers, ADA improvements, enhanced lighting, and other improvements that will facilitate connections, improve safety, or allow for strategic investment.”; Cancel 2022 “other” phase; add 2022 construction phase funded with \$620,577.29 FTA-5307 (incl. match). No change to project total.

**LTD frequent transit network (2022)**

Description: Transit passenger safety and amenity improvements along the frequent transit network to enhance safety and improve passenger experience.

Funding: \$835,840.86 (Urban STBG)

Amendment: Change description to read “Various safety and amenity improvements to the frequent transit network including shelter or station improvements, transit signal priority, wayfinding signage, bicycle lockers, ADA improvements, enhanced lighting, and other improvements that will facilitate connections, improve safety, or allow for strategic investment.”; Cancel 2022 “other” phase; add 2022 construction phase funded with \$835,840.86 Urban STBG (incl. match). No change to project total.

**Coburg Rd and Game Farm Rd**

Description: Pavement preservation to slow structural decline, restriping road surface and bringing curb ramps to ADA compliance to enhance safe transportation facilities and operations.

Funding: \$1,126,999.89 (Urban STBG)

Amendment: Add \$1,055,000.56 local funds to construction phase, new project total \$2,182,000.45.

Description: Repave the road to create a smoother driving surface and extend its useful life.

Funding: \$6,794,236.30 (Advance Construction – HB2017, R2 STBG)

Amendment: Update the project boundaries of MP 109.77 – 116.74 to now read MP 109.81 – 116.66

**S. 28th Street dust mitigation (Springfield)**

Description: Repave the road to create a smoother driving surface and extend its useful life.

Funding: \$1,915,029.12 (CMAQ, Local)

**21567 – Eugene**

**Lincoln St: 5th Ave. - 13th Ave. (Eugene)**

Description: Construct protected two-way cycle-track; add bicycle specific signal heads and phasing to existing traffic signals various other intersection improvements to increase safety of motorists, cyclists and pedestrians.

Funding: \$1,288,139.09 (HSIP, CMAQ)

Amendment: Slip 2021 preliminary engineering phase to 2022.

Description: Replace energy storage systems on hybrid buses

Funding: \$150,000 (5307)

Funding: \$200,000 (5307)

**20941 – LTD**

**Energy storage system replacement 2021 (LTD)**

Description: Replace energy storage systems on hybrid buses

Funding: \$300,000 (5307)

Amendments: Each project includes a 2021 other phase that will need to slip to 2022 for delivery.

**Systems synchronization upgrades – LTD**

Description: Upgrade to synchronize CAD ADL and security systems on buses and facilities.

Funding: \$5,000,000 (5307)

Amendment: Slip 2021 other phase to 2022 for delivery

Note: The grant application will be finalized and transmitted to FTA once TrAMS reopens in November.

**Security surveillance upgrades – LTD**

Description: Upgrade security surveillance at Lane Transit District (LTD) facilities.

Funding: \$2,500,000 (5307)

Amendment: Slip the 2021 preliminary engineering and 2021 construction phase to 2022 for delivery.  
Note: The grant application (1738-2021-7) will be finalized and transmitted to FTA once TrAMS reopens in November.

### **Information technology systems upgrade – LTD**

Description: Replacement of LTD's administrative information technology systems

Funding: \$3,125,000 (5307)

Amendment: Slip 2021 other phase to 2022 for delivery.

### **Household travel and activity survey**

Description: Central Lane MPO's participation in the statewide household travel and activity survey to inform travel analysis and model development.

## **21449 – Eugene**

### **Hunsaker Lane complete streets improvements**

Description: Complete the Beaver Street and Hunsaker Lane design and reconstruct Hunsaker Ln with curb, gutter, sidewalk, and east-bound and west-bound buffered bike lanes, and improve drainage ditch between Summer Ln and Yvonne to expand low-stress active transportation connectivity and access.

Funding: \$2,726,645.25 (Urban STBG, CMAQ)

Amendment: Slip 2021 preliminary engineering phase to 2022 for delivery.

## **21573 – Eugene**

### **City of Eugene Signal Improvements (2024)**

Description: Upgrade traffic signals at intersections to improve traffic flow and vehicle safety.

Funding: \$1,108,300 (HSIP)

Amendment: Slip 2021 preliminary engineering phase to 2022 for delivery.

## **22405 – Eugene**

### **Amazon Creek Bridge at Bailey Hill Rd (Eugene)**

Description: Strengthening of bridge #40039 on Bailey Hill Rd over Amazon Creek to help prevent damage from an earthquake.

Funding: \$667,000 (Urban STBG)

Amendment: Slip 2021 preliminary engineering phase to 2022 for delivery.

## **22340 – Coburg**

### **Central city corridor preservation (Coburg)**

Description: Preservation of central city roadway corridor to extend its useful life.

Funding: \$833,999.78 (Urban STBG)

Amendment: Slip 2022 preliminary engineering to 2023; slip 2023 construction to 2024 for delivery.

**21385 – Lane County**

**Gilham Road: Ayers Road to Mirror Pond Way**

Description: Design and build pavement and sidewalk improvements to extend useful life and improve pedestrian safety.

Funding: \$1,849,321.58 (CMAQ, Urban STBG)

Amendment: Slip 2022 construction phase to 2023 for delivery.
