## EMGO - DOWNTOWN EUGENE SHUTTLE IS HERE!

EMGo is Going!

LCOG has partnered with Lane Transit District (LTD), City of Eugene, Lane County and EWEB on a one year ondemand pilot project in downtown Eugene. This **FREE** service will provide on-demand rides within downtown Eugene using a downloaded app called TransLoc and you can download it <u>HERE</u>



EmGo cars operate from 7 a.m. to 6 p.m. Monday through Friday. The service area is from Fifth Avenue to 13th Avenue, and from Charnelton Street to High Street. There are 70 pickup locations scattered throughout the downtown area, as well as an EmGo stop near the Federal Courthouse at 405 E. Eighth Ave.

The vehicles are zero-emission, electric, six seater vans. The goal with this project is to alleviate parking issues and to encourage use of public transportation to and from downtown Eugene. Check it out when you are in downtown Eugene!

## **VENETA RECRUITS NEW CITY ADMINISTRATOR**

## THE 2020 CENSUS - COMPLETE COUNT COMMITTEE MEETING

LCOG is currently coordinating with the US Census Bureau to set up "Complete Count Committees". The Census Bureau wants local jurisdictions to involve community groups that can help bring in response from everyone but especially from hard-to-reach segments of the community: elderly shut-ins, Hispanic and non-white communities, homeless and transitional-shelter population, remote rural population, university students, etc.

The first meeting of the Lane County Complete Count Committee (CCC): Thursday, October 17, 2019 from 1:00 to 3:00

#### at LCOG, 859 Willamette Street, STE 500, Eugene

**Purpose:** The CCC will be charged with obtaining an accurate and complete population count for Lane County by:

 $\cdot$  Educating and informing residents of the importance of the census to them and their community.

• Motivating and engaging residents, with a focus on individuals in historically undercounted census tracts, to self-respond online to the 2020 Census. **Importance:** 

## Distribution of more than \$675 billion annually in federal funds back to tribal, state, and local governments.

- · Redistricting of state legislative districts.
- Forecasting future transportation needs for all segments of the population.
- Determining areas eligible for housing assistance and rehabilitation loans.

 $\cdot$  Assisting local government in planning and implementing programs, services, and emergency response.

• Designating facilities for people with disabilities, the elderly and children.

• The State of Oregon could gain a U.S. House of Representatives seat. **Goals:** 

• A complete count is vital for Lane County because so much federal and state funding is based upon the Decennial Census' population count.

Ensure an accurate count of every Lane County resident, including most likely undercounted communities.

• Make every Lane County resident aware of the Census, and the information

they provide for the Census is kept in complete confidence.

**Strategies:** The CCC will utilize the local knowledge, expertise, and influence of each member to develop and implement a census awareness campaign. Some ideas the CCC can undertake:

• Engage in community outreach efforts to communicate a unified brand and message of all Committee census activities.

• Work with stakeholders and community organizations to develop and coordinate targeted community outreach, education and census participation activities

· Incorporating census information in newsletters, social media posts, podcasts, mailings, and websites.

 $\cdot$  Develop efforts to drive participation among those populations that have historically been undercounted.

Increase the self-response rate for households responding online, by phone, or mailing back their questionnaire.

- · Develop strategies for non-response follow-up.
- Hold kickoff meetings with media briefings.
- · Participate in Census rallies or parades.
- · Host events.
- Help recruit census workers when jobs become available.
