We believe that this community deserves responsible, affordable, sustainable transit. Ideally it would be a system that will fit into our interior neighborhoods without requiring the divisive and expensive infrastructure needed by Lane Transit District's EmX bus rapid transit system.

Before the battle to extend EmX along Sixth and Seventh avenues in Eugene, the system had already been rejected on Coburg Road, West 11th Avenue and West 13th Avenue.

It is apparent from all the opposition that the EmX system requires too much infrastructure to be able to run in any already established area. These EmX buses are needlessly massive for a system that runs every 10 minutes.

Since EmX cannot be run through established neighborhoods, it is now relegated to main thoroughfares far from the residences the system should serve.

Just to qualify for federal funding, LTD plans to commandeer lanes that were built and designated to help all traffic flow.

Another notable factor: LTD builds concrete guideways for its heavy EmX buses but leaves the mixed traffic portion of its routes in asphalt, which will require repeated repairs at great cost to the city.

LTD could just implement full system traffic signal prioritization and minor intersection improvements to get all the benefit of EmX at 10 percent of the capital cost. This would also improve traffic flow for all without major impacts on the public and small businesses. Proper transit system management could be used to make all sides happy — if not for the corrupting influence of that "free" federal money.

The EmX system is neither fuel efficient nor flexible enough. It should have been demand-based, because it wastes massive amounts of fuel when ridership is down in off-peak directions and times.

When the ridership drops as low as the Gateway line, it becomes an environmental and economic disaster to run.

The west Eugene rider projections are even below the Gateway line and show no real need for this \$95 million extension.

The current cost of operating an LTD bus averages at least \$9.30 per mile. So operating a bus six times an hour over each 4.5 mile corridor will cost LTD \$2.2 million to \$2.4 million.

LTD never uses EmX-specific higher cost data and understates the operating costs by claiming operating costs of only \$1.2 million for EmX. But the EmX extension is only a partial replacement of existing routes.

When the miles and headways still needed to serve the rest of the route are calculated correctly, all savings vaporize, according to a independent traffic engineer's report commissioned by Our Money Our Transit.

These are precious revenues that are needed to preserve basic bus service elsewhere.

It is a real shame that LTD and the city of Eugene have felt the need to use underhanded tactics to push EmX through over the objections of

45 percent of the community. LTD should never have used tax dollars to monitor and suppress the opposition to its EmX plans. Furthermore, most EmX proponents are people who have a direct connection to LTD or would benefit from the construction of EmX. The city is also spending many thousands of tax dollars to battle the American Civil Liberties Union over free speech relating to "No EmX" signs.

Public input is the cornerstone of democracy, and LTD, with its unelected board, should never again try to circumvent it. Let your elected and non-elected officials know you know there are better solutions for transit in Lane County.
